SERVICE CONTRACT

THIS agreement between WATERWORKS DISTRICT NO. 1 OF WARD 1, CALCASIEU PARISH, LOUISIANA, organized and existing under and by virtue of the laws of the STATE OF LOUISIANA, hereinafter called the DISTRICT and whose signature is affixed hereto:

WITNESS:

WHEREAS, the USER, desires to purchase water from the District and to enter into a SERVICE CONTRACT for said purchase.

NOW, therefore, in consideration of the mutual covenants, promises, and agreements herein contained, it is hereby understood and agreed:

THE DISTRICT agrees to furnish subject to the limitations hereinafter provided for, such quantity of water for domestic, livestock, garden, industrial and commercial purposes as the USER may have delivered to him only such water as may be necessary to supply needs of the person's residing within a single farmstead or dwelling; and of the livestock owned by such persons and to irrigate a garden, that the industrial or commercial member shall be entitled to have delivered to him only such water as may be necessary to supply the needs of the particular installation.

The USER shall install and maintain at his own expense a service line which shall begin at his property line and extend to the dwelling and portions of his premises.

The USER shall pay for such water at such rates, time and place as shall be determined by the DISTRICT.

The DISTRICT shall install a meter and cut-off valve at each service and shall have exclusive rights to use cut-off valve and water meter and to turn it on and off.

The DISTRICT shall have final jurisdiction in any question of location of any service line connection to its distribution system; shall determine the portion of water to USER'S in the event of water shortage, may shut off water to a USER who allows a connection or extension to be made to his service line for the purpose of supplying water to another user; a service line CAN NOT be connected by a valve or any other way to a separate system of water well other than the DISTRICT'S SYSTEM.

The USER hereby agrees to deposit with the DISTRICT the amount applicable to be retained as a meter deposit to guarantee the payment of monthly bills. USER, also agrees to connect to the water system as soon as possible, when service becomes available and pay the prescribed rates. The deposits of those signers who fail to connect to the system after service becomes available shall FORFEIT their deposits or pay the minimum prescribed penalties:

- A. NON-PAYMENT, AFTER THE DUE DATE WILL BE SUBJECT TO A PENALTY OF FIVE PERCENT (5%) OF THE DELIQUENT ACCOUNT, WHICH PERCENT MAY BE CHARGED AT THE DISCRETION OF THE BOARD OF DIRECTOR'S.**
- B. SERVICE CHARGES WILL BE IMPOSED TO THE CUSTOMER IN THE EVENT PAYMENT IS NOT RECEIVED TEN DAYS (10) AFTER THE DUE DATE. FAILURE TO COMPLY WITH DELIQUENT ACCOUNT WILL RESULT IN DISCONNECTION OF WATER SERVICE. RECONNECTION WILL REQUIRE THAT THE TOTAL BILL BE PAID IN FULL AND A SERVICE CHARGE FOR COLLECTION PLUS ANOTHER SERVICE CHARGE FOR RECONNECTION WILL BE CHARGED.**

ANY INACTIVE ACCOUNT THAT HAS A BALANCE OWING WITH THE DISTRICT MUST BE PAID WITHIN THIRTY (30) DAYS OF DISCONNECTION OR THE ACCOUNT WILL BE TURNED OVER TO A CREDIT BUREAU FOR COLLECTIONS.
